Intermediate Level: 10<sup>th</sup> grade or lower  
Senior Level: 12<sup>th</sup> grade or lower

**Note: Students may win only once at any level. First-place winners or concert performers from the previous year may not participate in the competition this year. Senior Level winners/performers are no longer eligible to participate in this event.**

## **Rules:**

1. Performers are required to use the MSMTA accompanist at the event.
2. Students may enter a maximum of three movements. However, they can only be declared the winner for one movement.
3. Students must perform from memory.
4. At the discretion of the judges, winners may not be selected. A maximum of two students may be selected as winners (Team I and Team II) for each movement.
5. All winners are expected to perform in the winners' concert and attend rehearsals with the selected orchestra. If the winner in either team cannot participate in the winners' concert, then Team I alternate will be asked to perform; if Team I alternate is not available, then Team II alternate will be asked to perform.
6. Application fees should arrive within two days of the application submission. There will be no refund for the application fees once submitted.
