Elementary: Grades 4-6, ONE movement from Solo Suite (Duration: 4 minutes)

Intermediate: Grades 7-9, Prelude and a movement from the same suite (Duration: 7 minutes)

Advanced: Grades 10-12, Prelude and two contrasting movements from the same suite (Duration: 10 minutes)

College: Prelude and two contrasting movements from Suite 4, 5, or 6 (Duration: 15 minutes)

Violin

Elementary: Grades 4-6: Any movement from Partita or Sonata (Duration: 4 minutes)

Intermediate: Grades 7-9: Two contrasting movements from Partita or Sonata (Duration: 7 minutes)

Advanced: Grades 10-12: Introductory movement from a Sonata, a contrasting movement from a Sonata or Partita (Duration: 10 minutes)

College: Chaconne, introductory movement from a Sonata, a contrasting movement from a Sonata or Partita (Duration: 15 minutes)

All movements for each level must be memorized.
